These amounts represent goals to award in 2024. Some funds will remain for awarding in 2025. There is flexibility to shift award amounts across the first four categories, based on needs identified by institutions.





Award Highlights

- ✓ Up to \$1M for implementing system changes based on promising practices to increase adult completion rates.
- Public & tribal community colleges and public universities serving the adult learner population, defined as adults over the age of 25.
- Independent colleges may partner with a public institution on a joint application but cannot be the lead applicant.
- ✓ Grants run through the end of August, 2026.







Promising Practices

- There is no silver bullet to improving adult completion rates.
- It's a combination of effective strategies that begins with a commitment to continually engaging adults to learn how to best meet their needs.
 - Proactive, comprehensive advising
 - Prior learning assessments
 - Credit for prior learning
 - Competency-based education
 - Flexible scheduling
 - Eliminating barriers to transfer

- Work based learning opportunities
- Holistic basic needs support
- Career-aligned, guided pathways
- Corequisite learning
- Systematic approach to basic needs

System Change

Deliberate and comprehensive efforts to transform various aspects of the educational system. This involves addressing fundamental structures, processes, policies, and practices within higher education institutions to create positive and sustainable impacts. For the Innovation Investment Awards, the change will focus on supporting adult learners.

System Change Elements

- **Structural Reforms:** This involves rethinking and reconfiguring organizational structures within institutions, such as administrative hierarchies, departmental structures, and decision-making processes.
- **Policy Revisions:** Identifying, revising, or creating new policies that support adult learners. This may involve changes in admissions policies, financial aid structures, and curriculum development.
- **Cultural Shifts:** Promoting a culture of innovation, collaboration, and continuous improvement within the institution to support adult learners. This may involve fostering a climate that values diversity, encourages interdisciplinary collaboration, and supports experimentation and risk-taking.

- Technology Integration: Leveraging technology to enhance teaching, learning, and administrative processes to support adult learners. This could include implementing improvements to learning management systems, online learning platforms, and data analytics tools that support adult student success efforts.
- **Community Engagement:** Engaging stakeholders both within and outside the institution, including students, faculty, staff, alumni, community partners, and policymakers. This may involve seeking input, building partnerships, and mobilizing resources to support institutional goals, priorities and programs to support adult learners.
- **Sustainability:** Ensuring that changes are sustainable over the long term by considering the environmental, economic, and social impacts of institutional practices and decisions.





Eligible Expenses

- FTE attributable to proposed project implementation
- Costs of consultants, vendors, and other contractors necessary for the project
- Costs for training of staff, faculty, or partners related to the project
- Travel expenses directly related to the project implementation (align with federal GSA rates)

- Supplies, materials, or other collateral necessary for project implementation
- Expenses related to the design and implementation of data systems related to the project and its evaluation*

*Data system updates, NOT replacement of an entire data system.





Ineligible Expenses

- Direct aid to students (emergency loans, textbook fund, etc.)
- Food and beverage
- Indirect costs (see SLFRF guidance)
- Tuition
- Replacement of an entire data system

Utilize office hours and early review process to discuss expense proposals.

- Maximum score 80 points
- Required Elements 14 points
 - Letter of Organizational Support
 - Executive Summary
 - Project Narrative explains how labor market needs are addressed
 - Evaluation metrics proposed
 - Grant Budget within parameters, with minimum 10% matching funds
 - Institutional Commitments checked in the affirmative

Institutional Commitments

- ✓ 10% matching funds (can include in-kind)
- Monthly meeting with President and project team
- ✓ Commitment to mentoring other institutions
- ✓ Quarterly meetings with The Center to accelerate implementation
- Periodic engagement with The Center to document the change process
- Data Sharing Agreement and participate in external evaluation process

 - Request is feasible for organization's commitment and resources to carry out funded activities
 - Integration of matching funds, with plans to sustain the change beyond the grant period
- Planning Process 12 points
 - MI-RAISE Design Lab/D3C3 participation (12 pts) or other thoughtful planning process (6 pts) demonstrated in narrative









Center & Sixty by 30 Coordination

- ✓ The Michigan Center for Adult College Success & the Sixty by 30 Office are coordinating on the grant opportunities.
- $\checkmark\,$ The IIA grants are intentionally aligned to the Accelerate and Go Big Sixty by 30 grants.
- $\checkmark\,$ Institutions can apply for both the IIA grants and the Sixty by 30 grants.
- ✓ If the identical proposal is submitted to both entities The Center and Sixty by 30 will coordinate on the award.
- ✓ If institutions apply for both with different proposals, The Center and Sixty by 30 will seek a conversation with the institution to ensure there is capacity to execute both programs simultaneously.





IIA Recipient Supports

- ✓Co-develop evaluation criteria
- ✓ Logic-model development assistance
- ✓ Center data and research support
- ✓ Access to coaches or subject matter experts from The Center
- Access to Center's resources to help identify additional partners or supports

The aim is to learn and share what works to get results for adult learner completion.
